The Bali Process Regional Support Office (RSO) was established in 2012 to provide technical support to the Bali Process and to strengthen regional cooperation on refugee protection and international migration, including human trafficking and people smuggling. The RSO is the only cooperation mechanism of its kind in the region.

We bring together relevant:

- **policy** knowledge;
- **technical** expertise; and
- **operational** experience

from Bali Process members and other key stakeholders to develop **practical initiatives** that address people smuggling, trafficking in persons and related transnational crime.



The *Bali Process on People Smuggling, Trafficking in Persons and Related Transnational Crime* (Bali Process) was established in 2002 to focus on long-term strategies to address the crimes of people smuggling, trafficking in persons and other related transnational crime in Asia and the Pacific.

We work with our stakeholders on initiatives that improve regional ability to identify and respond to trafficking in persons, people smuggling and related issues.

The RSO develops policy tools, holds workshops and conducts training on a range of issues relevant to the Bali Process. This has included asylum procedures, screening travel documents, designing effective information campaigns, and implementing assisted voluntary return programmes.

In February 2017 the RSO launched the Regional Strategic Roadmap, an online portal that supports Member States to evaluate and improve responses to trafficking in persons.
